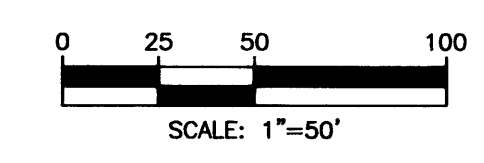
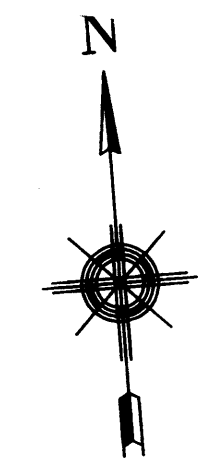


PROJECT LOCATION

COMMENCING at a 1/2-inch iron set for the southwest corner of Block 62, of the Original Townsite of the City of Bryan, from which a 1/2-inch iron rod found bears N 04° 44' 14" E 250.00 feet, same being along the existing north right of way line of East 26th Street and in the existing east right of way of Preston Street (80' right of way);

THENCE N 04° 44' 14" E 115.00 feet, along the existing east right of way line of Preston Street, same being the northwest corner of Lot 1, Block 62 of the Original Townsite of the City of Bryan to the PLACE OF BEGINNING;

THENCE N 04° 44' 14" E 20.00 feet, along the existing east right of way line of Preston Street, same being the southwest corner of Lot 6, Block 62 of the Original Townsite of the City of Bryan to a point for corner;

THENCE S 85° 15' 46" E, 250.00 feet along the south line of Lot 6, Lot 7, Lot 8, Lot 9 and Lot 10 Block 62 of said Original Townsite of the City of Bryan, to the west line of Polk Street, (abandoned 80' right of way by Ordinance No. 632), same being the southeast corner of Lot 10, Block 62 of the Original Townsite of the City of Bryan to a point for corner;

THENCE S 85° 15' 46" E 580.00 feet, along the existing north right of way line of East 26th Street, to a 1/2-inch iron rod set for corner, same being the southeast corner of Block 71, of the Original Townsite of the City of Bryan, from which a 1/2-inch iron rod found, bears N 71° 58' 42" W 2.29 feet;

THENCE S 45° 00' 00" W 26.21 feet to a "x" cut in concrete for corner;

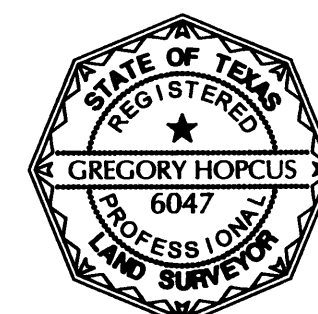
