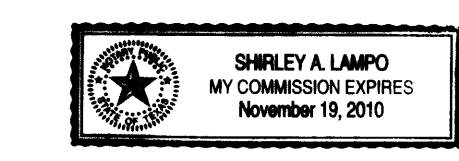

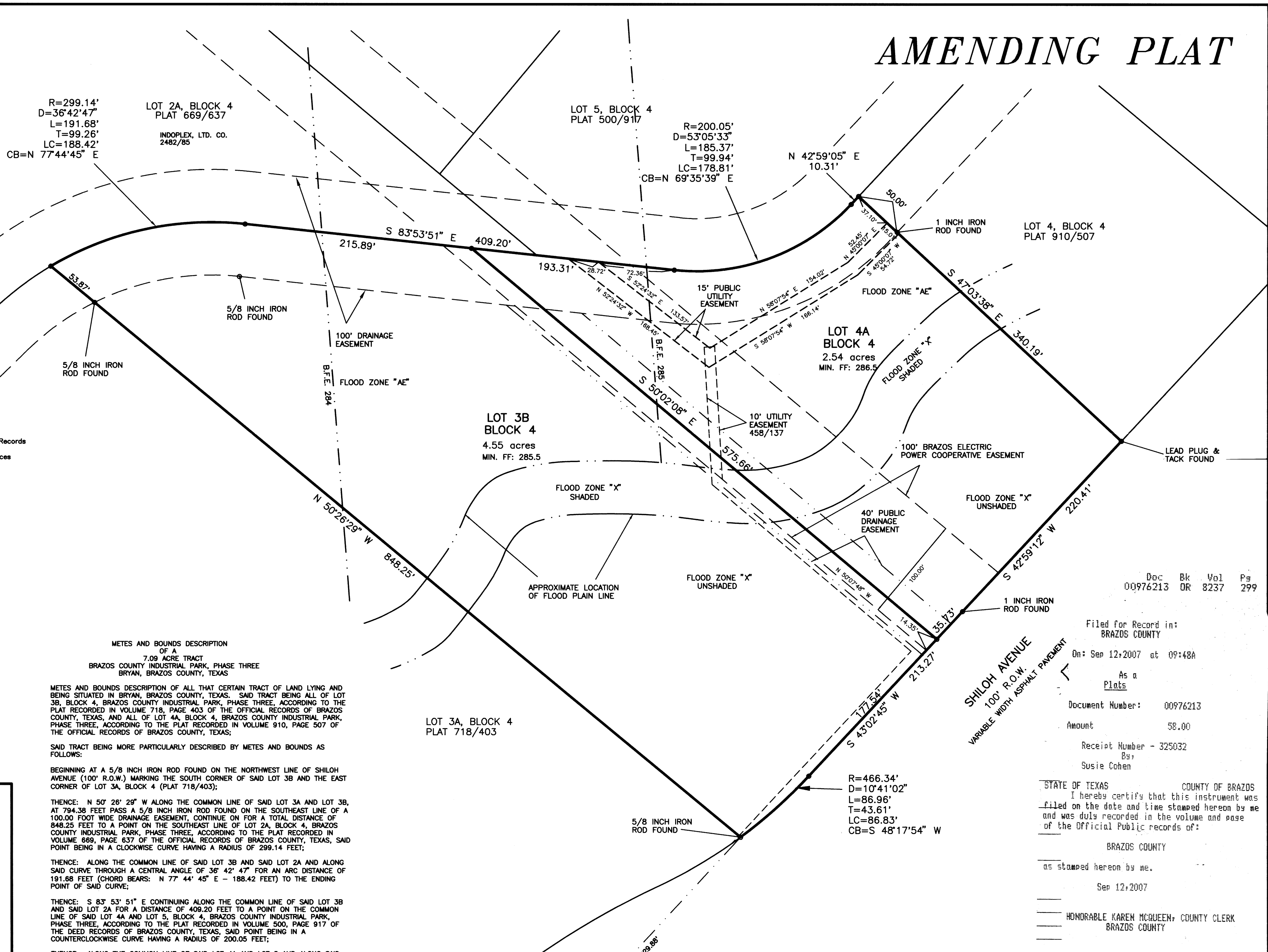
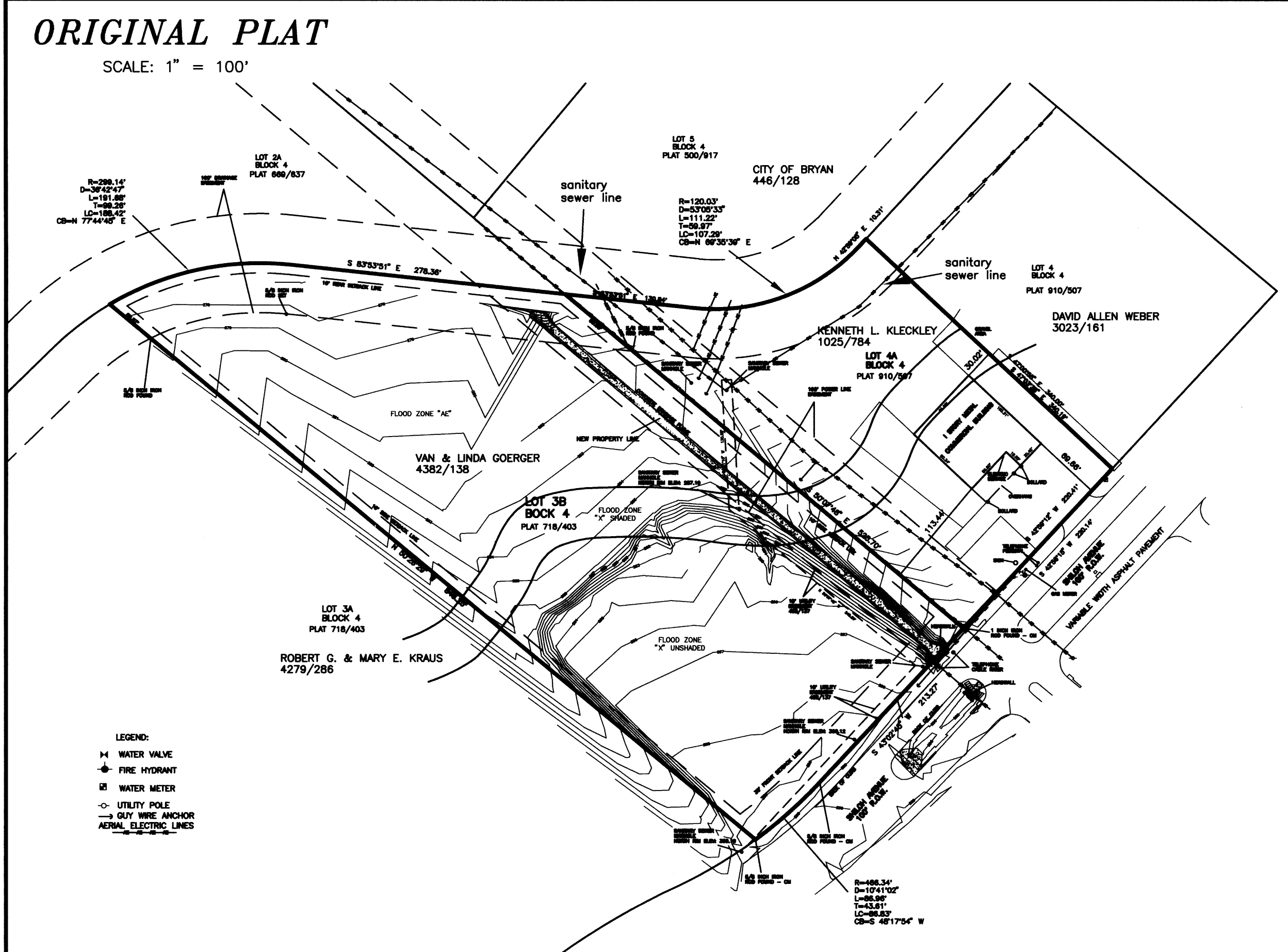

METES AND BOUNDS DESCRIPTION OF ALL THAT CERTAIN TRACT OF LAND LYING AND BEING SITUATED IN BRYAN, BRAZOS COUNTY, TEXAS. SAID TRACT BEING ALL OF LOT 3B, BLOCK 4, BRAZOS COUNTY INDUSTRIAL PARK, PHASE THREE, ACCORDING TO THE PLAT RECORDED IN VOLUME 718, PAGE 403 OF THE OFFICIAL RECORDS OF BRAZOS COUNTY, TEXAS, AND ALL OF LOT 4A, BLOCK 4, BRAZOS COUNTY INDUSTRIAL PARK, PHASE THREE, ACCORDING TO THE PLAT RECORDED IN VOLUME 910, PAGE 507 OF THE OFFICIAL RECORDS OF BRAZOS COUNTY, TEXAS.

SAID TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A 5/8 INCH IRON ROD FOUND ON THE NORTHWEST LINE OF SHILOH AVENUE (100' R.O.W.) MARKING THE SOUTH CORNER OF SAID LOT 3B AND THE EAST CORNER OF LOT 3A, BLOCK 4 (PLAT 718/403);

THENCE: N 50° 28' 29" W ALONG THE COMMON LINE OF SAID LOT 3A AND LOT 3B, AT 794.38 FEET PASS A 5/8 INCH IRON ROD FOUND ON THE SOUTHWEST LINE OF A 100.00 FOOT WIDE DRAINAGE EASEMENT, CONTINUE ON FOR A TOTAL DISTANCE OF 848.25 FEET TO A POINT ON THE SOUTHWEST LINE OF LOT 2A, BLOCK 4, BRAZOS COUNTY INDUSTRIAL PARK, PHASE THREE, ACCORDING TO THE PLAT RECORDED IN VOLUME 669, PAGE 637 OF THE OFFICIAL RECORDS OF BRAZOS COUNTY, TEXAS, SAID POINT BEING IN A CLOCKWISE CURVE HAVING A RADIUS OF 299.14 FEET;

THENCE: ALONG THE COMMON LINE OF SAID LOT 3B AND SAID LOT 2A AND ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 36° 42' 47" FOR AN ARC DISTANCE OF 191.88 FEET (CHORD BEARS: N 77° 44' 45" E - 188.42 FEET) TO THE ENDING POINT OF SAID CURVE;

THENCE: S 83° 53' 51" E CONTINUING ALONG THE COMMON LINE OF SAID LOT 3B AND SAID LOT 2A FOR A DISTANCE OF 409.20 FEET TO A POINT ON THE COMMON LINE OF SAID LOT 4A AND LOT 5, BLOCK 4, BRAZOS COUNTY INDUSTRIAL PARK, PHASE THREE, ACCORDING TO THE PLAT RECORDED IN VOLUME 500, PAGE 917 OF THE DEED RECORDS OF BRAZOS COUNTY, TEXAS, SAID POINT BEING IN A COUNTERCLOCKWISE CURVE HAVING A RADIUS OF 200.05 FEET;

THENCE: ALONG THE COMMON LINE OF SAID LOT 4A AND SAID LOT 5 AND ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 53° 05' 33" FOR AN ARC DISTANCE OF 185.37 FEET (CHORD BEARS: N 69° 35' 39" E - 178.81 FEET) TO THE ENDING POINT OF SAID CURVE;

THENCE: N 42° 59' 05" E CONTINUING ALONG THE COMMON LINE OF SAID LOT 4A AND LOT 5 FOR A DISTANCE OF 10.31 FEET TO A POINT MARKING THE COMMON CORNER OF SAID LOT 4A AND LOT 4, BLOCK 4 (PLAT 910/507);

THENCE: S 47° 03' 38" E ALONG THE COMMON LINE OF SAID LOT 4A AND SAID LOT 4, AT 50.00 FEET PASS A 1 INCH IRON ROD FOUND, CONTINUE ON FOR A TOTAL DISTANCE OF 340.19 FEET TO A LEAD PLUG AND TACK FOUND ON THE NORTHWEST LINE OF SHILOH AVENUE MARKING THE COMMON CORNER OF SAID LOT 4A AND LOT 4;

THENCE: S 42° 59' 12" W ALONG THE NORTHWEST LINE OF SHILOH AVENUE FOR A DISTANCE OF 220.41 FEET TO A 1 INCH IRON ROD FOUND MARKING THE COMMON CORNER OF SAID LOT 3B AND LOT 4A;

THENCE: S 43° 02' 45" W CONTINUING ALONG THE NORTHWEST LINE OF SHILOH AVENUE FOR A DISTANCE OF 213.27 FEET TO A POINT MARKING THE BEGINNING OF A CLOCKWISE CURVE HAVING A RADIUS OF 466.34 FEET;
