BEGINNING at a concrete monument found marking the north corner of the herein described tract, said monument also being located in the southeast right-of-way of Briarcrest Drive, said monument also being located in the southwest right-ofway of State Highway No. 6 East By-Pass;

THENCE S $36^{\circ}57'00"$ E along the southwest right-ofway of the aforementioned State Highway No. 6 East By-Pass for a distance of 207.18 feet to an iron rod for corner;

THENCE S 36°56'58" E continuing along the southwest right-of-way of the aforementioned State Highway No. 6 East By-Pass for a distance of 619.40 feet to an iron rod for corner;

THENCE S 46°29'45" W for a distance of 814.71 feet to an iron rod for corner, said iron rod being located in the northeast right-of-way of Freedom Boulevard;

THENCE N 44°18'38" W along the northeast right-of way of the aforementioned Freedom Boulevard for a distance of 831.23 feet to a concrete monument for corner, said concrete monument also being located in the southeast right-of-way of Briarcrest Drive;

THENCE N 45°41'22" E along the southeast right-ofway of the aforementioned Briarcrest Drive for a distance of 723.52 feet to a concrete monument for corner;

THENCE N 52°19'34" E continuing along the southeast right-of-way of the aforementioned Briarcrest Drive for a distance of 198.34 feet to the PLACE OF BEGINNING containing 16.653 acres of land, more or less.
