


## LOCATION MAP

## FIELD NOTES

Being all that certain tract or parcel of land, lying and being situated in the ZENO PHILLIPS LEAGUE in Bryan, Brazos County, Texas, and being all of lot 13 and part of lot 16 of MILTREE PLACE according to a plat recorded in Volume 129, page 395 of the Deed Records of Brazos County, Texas, and being more particularly described as follows:

BEGINNING: at an iron rod found at the West corner of said lot 13, said iron rod being in the southeast right-of-way line of DELLWOOD STREET;

THENCE: N 45°19'23" E - 142.50 feet along said Dellwood St. line to an iron rod at it's intersection with the southwest right-of-way line of Cavitt Ave;

THENCE: S:47°20'00" E - 576.91 feet along said Cavitt Ave. line to an iron rod at it's intersection with the southwest right-of-way line of Villa Maria Rd.;

THENCE: S 51°16'44" W - 195.02 feet along said Villa Maria Rd. line to an irongrod for corner;

THENCE: N 38°51'53" W - 100.28, N 46°53'12" W - 136.00 feet and N 41°08'12" W - 321.00 feet to the PLACE OF BEGINNING and containing 2.20 acres of land, more or less.
