A FIELD NOTES DESCRIPTION OF A 5' WIDE SANITARY SEWER EASEMENT IN THE ZENO PHILLIPS LEAGUE NO. 7 SURVEY, ABSTRACT 45, IN BRYAN, BRAZOS COUNTY, TEXAS, DESCRIBED IN VOLUME 923, PAGE 611 OF THE OFFICIAL RECORDS OF BRAZOS COUNTY, TEXAS (ORBCT), ACROSS A CALLED 0.332 ACRE TRACT ONE AND A CALLED 0.112 ACRE TRACT TWO, BOTH DESCRIBED IN A DEED TO OLD TOWN BUILDERS, LLC IN VOLUME 18250, PAGE 215 OF THE OFFICIAL PUBLIC RECORDS OF BRAZOS COUNTY, TEXAS (OPRBCT); SAID EASEMENT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a point on the southwest right-of-way of Cavitt Avenue (variable width right-of-way) and on the northeast line of said Tract Two, from which a 5/8 inch iron rod found (all 5/8 inch iron rods found with blue plastic caps stamped "KERR SURVEYING") marking intersection of the southeast right-of-way of Edge Street (50 foot wide right-of-way, 70/247 DRBCT) and marking the north corner of said Tract Two; also for reference from said Point of Beginning the City of Bryan GPS monument 107 bears N 28° 25' 10" W a distance of 1,509.11 feet;

THENCE, with said right-of-way of Cavitt Avenue, **S 37° 26' 27" E** a distance of **5.47 feet** to a point for corner from which a 5/8 inch iron rod found marking the northeast corner of said Tract Two and called 0.120 acre Tract Three (18250/215 OPRBCT) bears S 37° 26' 27" E a distance of 25.28 feet;

THENCE, over, across, and upon said Tract Two and Tract One, **S 76° 24' 50" W** a distance of **126.10 feet** to a point on said southeast right-of-way of Edge Street and the northwest line of said Tract One;

THENCE, with said right-of-way, **N 55° 40' 17" E** a distance of **14.12 feet** to a point on said right-of-way; from which a 5/8 inch iron rod found marking the northwest common corner of said Tract One and Tract Two bears N 55° 40' 17" E a distance of 29.12 feet:

THENCE, over, across, and upon said Tract One and Tract Two, **N 76° 24' 50" E** a distance of **110.68 feet** to the **POINT OF BEGINNING** hereof and containing **0.014 acre** (~**592 sq. ft.**), more or less.

Surveyed on the ground in 2022 and 2024 under my supervision. See exhibit prepared May 2024 for other information. The bearing basis for this survey is based on the Texas State Plane Coordinate System of 1983 (NAD83), Central Zone, Grid North as established from GPS observation using the Leica Smartnet NAD83 (NA2011) Epoch 2010 Multi-year CORS Solution 2 (MYCS2). Distances described herein are surface distances. To obtain grid distances (not grid areas) divide by a combined scale factor of 1.00010940206389 (calculated using GEOID12B).
