AUSTIN LEAGUE No. 10, Abstract No. 63, in Bryan, Brazos County, Texas and being part of the called 96.597 acre remainder tract described in the deed from Harrison Holdings Limited Partnership, a Texas limited liability partnership to BORD, LLC, a Texas limited liability company recorded in Volume 14807, Page 198 of the Official Public Records of Brazos County, Texas (O.P.R.B.C.) and being more particularly described by metes and bounds as follows:

- COMMENCING: from a found 1/2-inch iron rod marking the west corner of Lot 1, Block 9, RUDDER POINTE, PHASE 3 according to the Final Plat recorded in Volume 17219, Page 240 (O.P.R.B.C.) and being in the northeast line of the called 202.3 acre Harrison Holdings Limited Partnership remainder tract recorded in Volume 6542, Page 177 of the Official Records of Brazos County, Texas (O.R.B.C.);

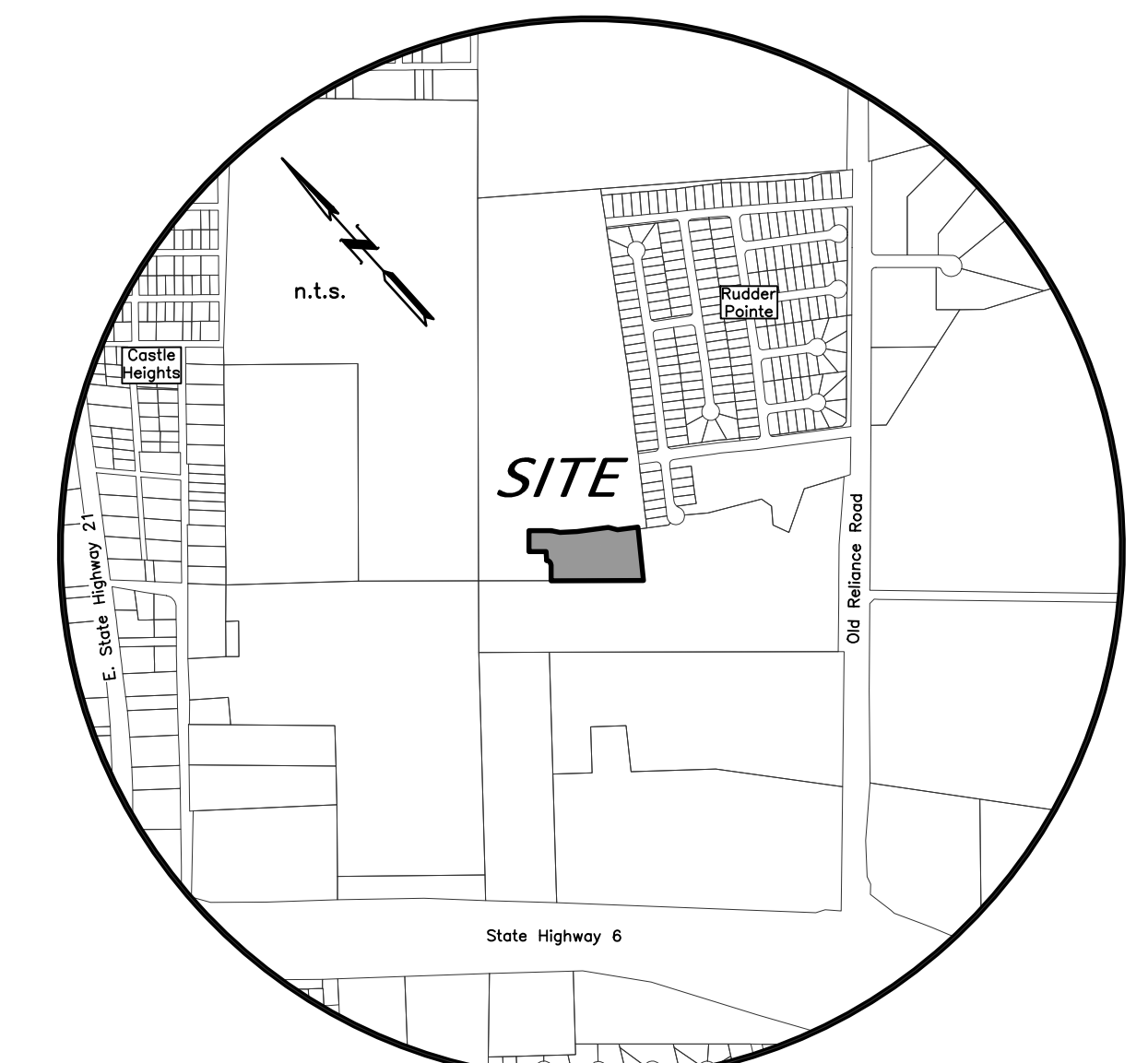

 3. Unless otherwise indicated, all distances shown along curves are arc distances.
 4. The subject property is zoned Planned Development - Housing District (PD-H) by the Bryan City Council on May 14, 2024, with Ordinance No. 2692.
 5. All minimum building setbacks shall be in accordance with the City of Bryan Code of Ordinances.
 6. Right-of-way Acreage: 0.90 Ac.
 7. A Homeowner's Association (H.O.A.) shall be established with direct responsibility to, and controlled by, the property owners involved to provide for operation, repair and maintenance of all common areas, private drainage easements, and private stormwater detention facilities which are part of this subdivision. The City of Bryan shall not be responsible for any operation, repair and maintenance of these areas.
 8. Where electric facilities are installed, B.T.U. has the right to install, operate, relocate, construct, reconstruct, add to, maintain, inspect, patrol, enlarge, repair, remove and replace said facilities upon, over, under, and across the property included in the P.U.E., and the right of ingress and egress on property adjacent to the P.U.E. to access electric facilities.
 9. Bryan Parks and Recreation Advisory Board approved the proposed Rudder Pointe Park improvements on February 20, 2024.
 10. Unless otherwise indicated 1/2" Iron Rods are set at all corners.
