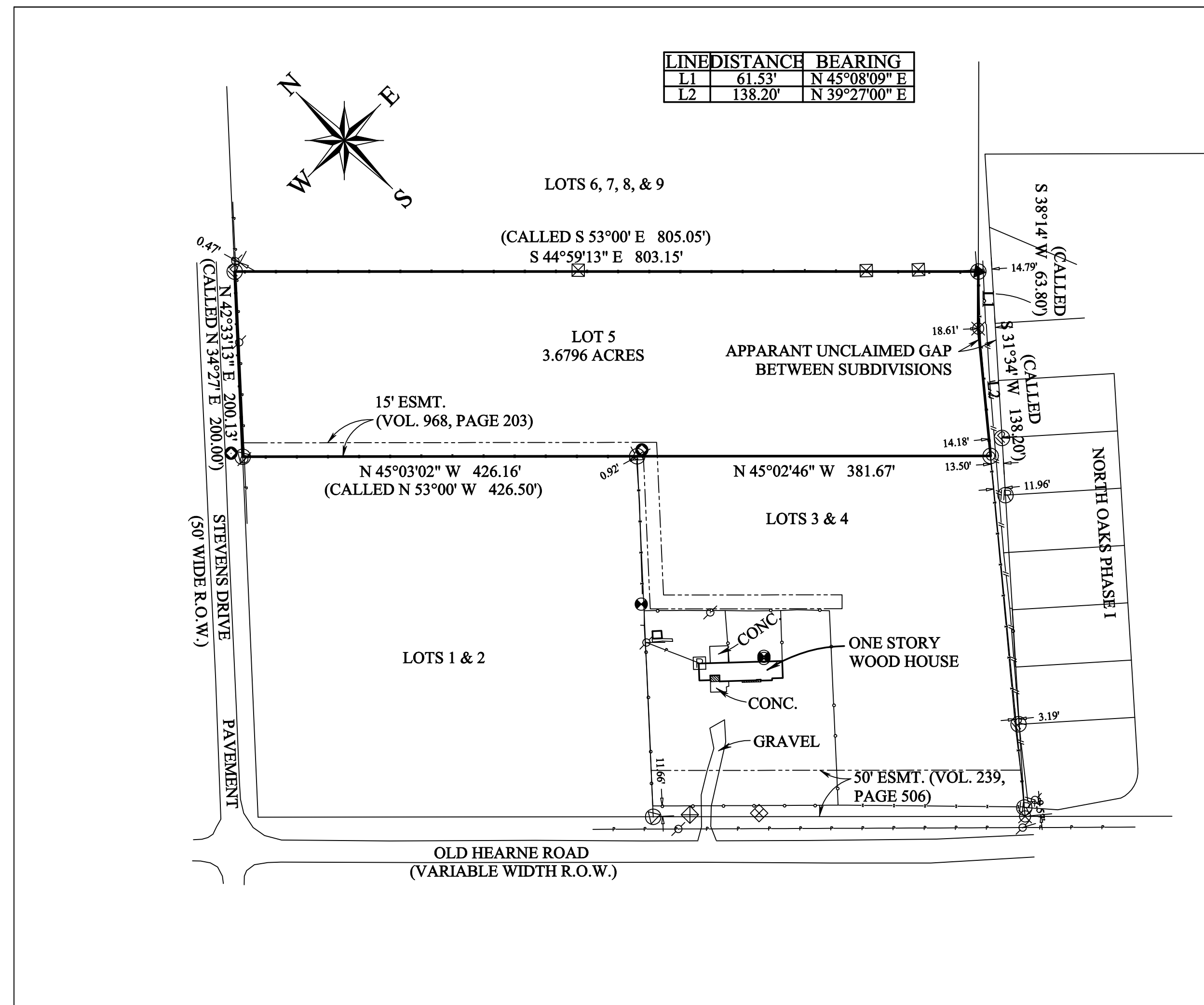


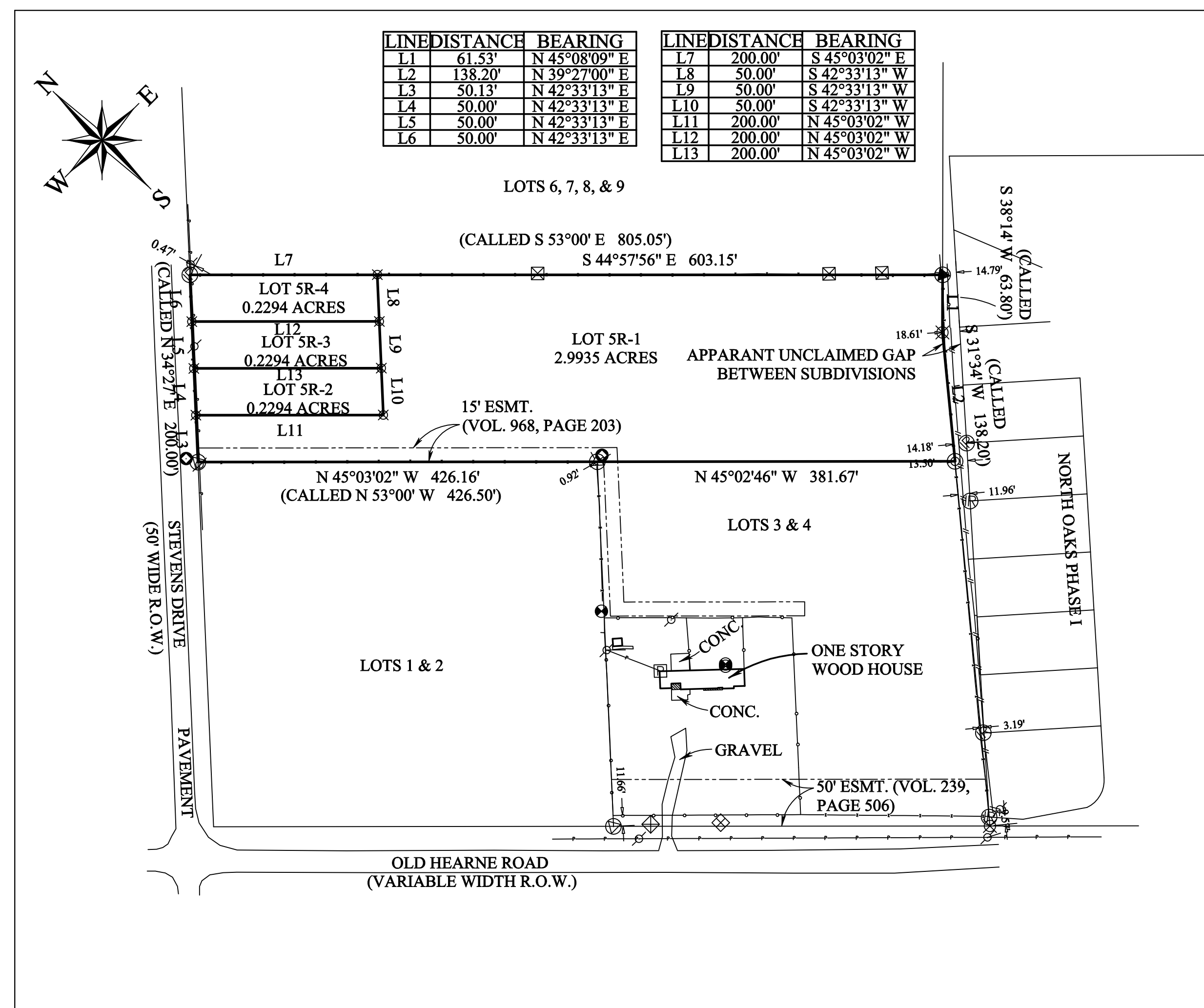
PROJECT LOCATION

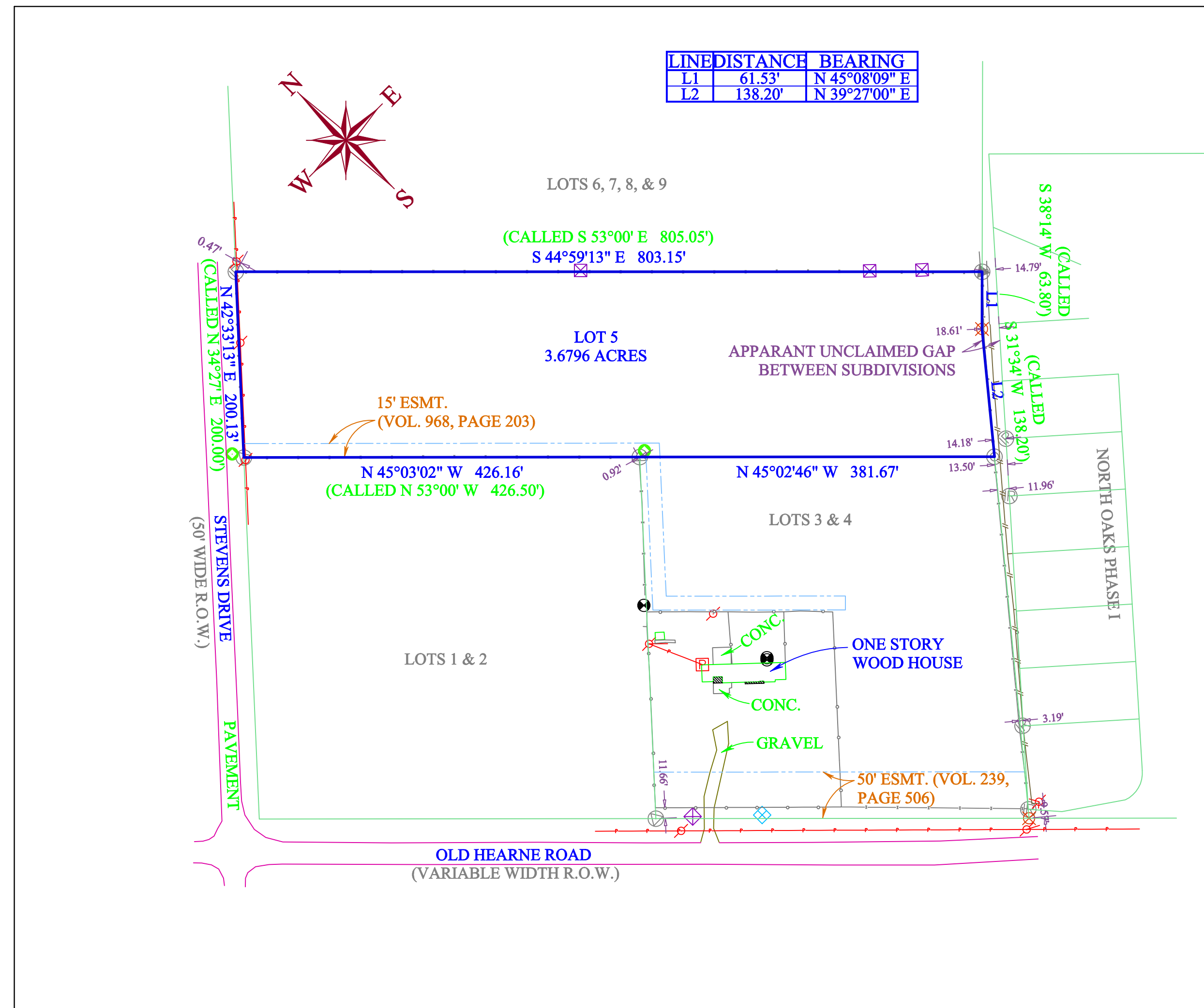

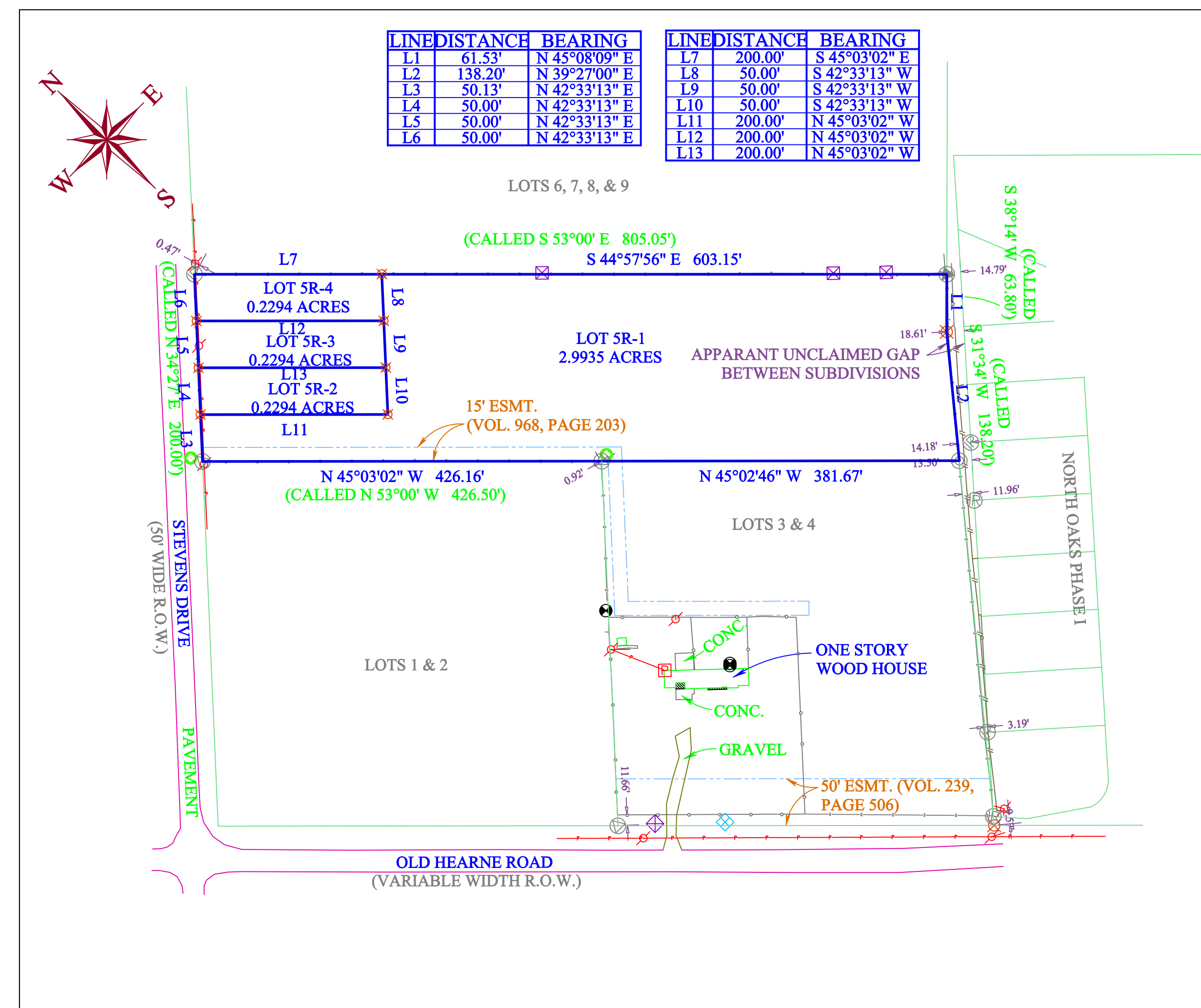
PROJECT LOCATION
