METES AND BOUND DESCRIPTION Being a tract of land containing 1.098 acres in the Moses Baine Survey, A-8, City of Bryan, Brazos County, Texas, being the same tract as recorded in Vol. 8875, Page 33 of the Brazos County Official Records (B.C.O.R.). All bearings of this survey are referenced to the Texas State Plane Coordinate System, Central Zone, NAD83(2011) Epoch 2010, and boundary referenced to 1/2" and 5/8" iron rods called for and found as noted in the previously recorded deed, and as surveyed on the ground on March 12th of 2024. This description is also referred to the plat prepared by ATM Surveying, Project No. 2023-05922, and being more particularly described as follows:
