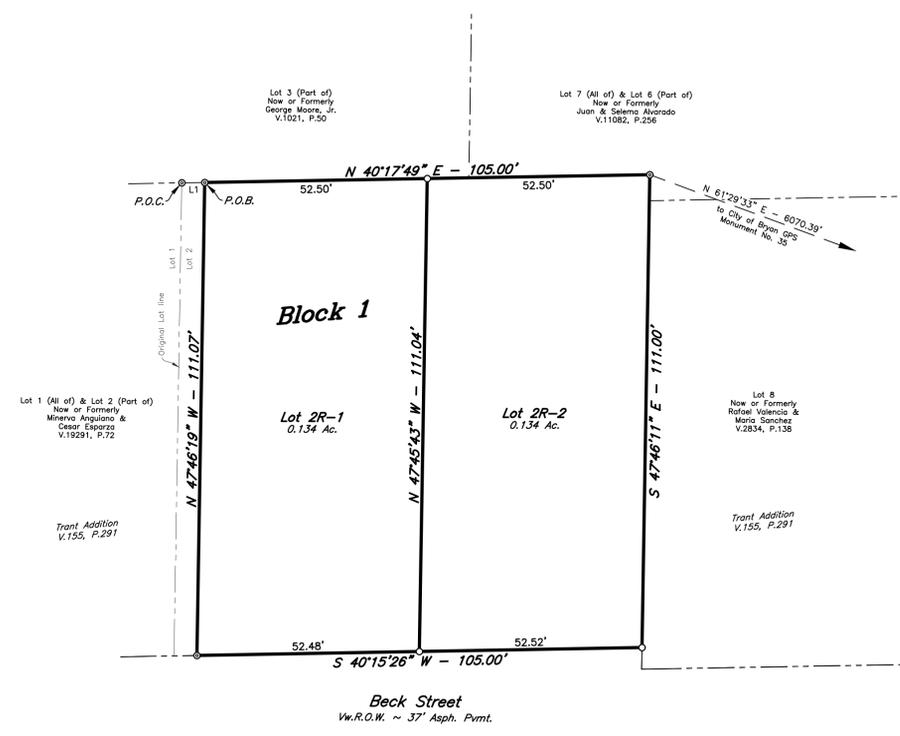

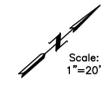

**FIELD NOTES**

Being all that certain tract or parcel of land lying and being situated in the STEPHEN F. AUSTIN LEAGUE NO. 9, Abstract No. 62, in Bryan, Brazos County, Texas and being part of Lot 2, Block 1, TRANT ADDITION according to the Final Plat recorded in Volume 155, Page 291 of the Brazos County Deed Records (B.C.D.R.), said Lot 2, Block 1 being further described in the deed from Maria Nieves Serna to Atanasio Valadez recorded in Volume 19638, Page 166 of the Official Public Records of Brazos County, Texas (O.P.R.B.C.) and being more particularly described by metes and bounds as follows:

COMMENCING: at a found 5/8-inch iron rod marking the west corner of said Lot 2, Block 1, said iron rod also marking the north corner of Lot 1, Block 1 of said TRANT ADDITION and being in the southeast line of Lot 3, Block 1 of said TRANT ADDITION;

THENCE: N 40° 17' 49" E along the common line of said Lot 2, Block 1 and said Lot 3, Block 1 for a distance of 5.40 feet to a found 5/8-inch iron rod marking the west corner of this herein described tract and the POINT OF BEGINNING;

THENCE: N 40° 17' 49" E along the common line of this tract, said Lot 3, Block 1 and Lot 7, Block 1 of said TRANT ADDITION for a distance of 105.00 feet to a found 5/8-inch iron rod marking the common north corner of this tract and said Lot 2, Block 1;

THENCE: S 47° 46' 11" E along the common line of this tract, said Lot 7, Block 1 and Lot 8, Block 1 of said TRANT ADDITION for a distance of 111.07 feet to a 1/2-inch iron rod set for the common east corner of this herein described tract and said Lot 2, Block 1, said iron rod also being in the northwest right-of-way line of Beck Street (based on variable width);

THENCE: S 40° 15' 26" W along the northwest right-of-way line of said Beck Street for a distance of 105.00 feet to a found 5/8-inch iron rod marking the south corner of this tract;

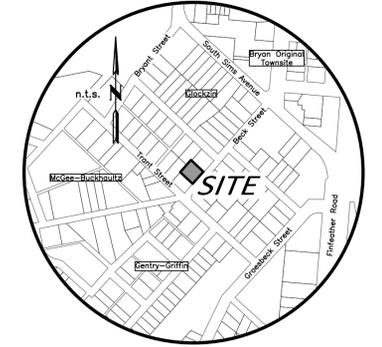
THENCE: N 47° 46' 19" W into and through said Lot 2, Block 1 for a distance of 111.07 feet to the POINT OF BEGINNING and containing 0.267 acres of land.

- GENERAL NOTES:**
- ORIGIN OF BEARING SYSTEM: The bearing system shown hereon is Grid North, Texas State Plane Coordinate System, Central Zone, NAD83 per GPS observations and actual measured distance to the monuments are consistent with the plat recorded in Volume 155, Page 291 of the Brazos County Deed Records.
  - According to the FEMA Flood Insurance Rate Maps for Brazos County, Texas and Incorporated Areas, Map Numbers 48041C0195E, Map Revised May 16, 2012 and LOMR 12-06-1920P, effective date May 9, 2014, no portion of this property is located within a Special Flood Hazard Area.
  - Where electric facilities are installed, BTU has the right to install, operate, relocate, construct, reconstruct, add to, maintain, inspect, patrol, enlarge, repair, remove and replace said facilities upon, over, under, and across the property included in the P.U.E., and the right of ingress and egress on property adjacent to the P.U.E. to access electric facilities.
  - This property is currently zoned Residential District - 5000 (RD-5).
  - Building setbacks per City of Bryan Code of Ordinance. Additional building setbacks may be required by deed restrictions.

  - Unless otherwise indicated 1/2" Iron Rods are set at all corners.
