## ***THE CHIEF'S MESSAGE***

On behalf of the Bryan Police Department, I am pleased to present the Annual Report for the year 2020. This report recognizes many of our Department's achievements for the past year. As you review this report, you will see that our organization is dynamic and continually seeking improvement in order to provide excellent police services for our community. It is a privilege to lead this department.

The Bryan Police Department is committed to Community Oriented Policing. As a Police Department, we are active, engaged members of the Bryan community. Our officers attend and participate in numerous community events. We lead through our programs such as the Neighborhood Enforcement Team (NET), our English-language, Youth, and Spanish-language Citizen Police Academies, although due to COVID our Citizen Police Academies were postponed in 2020. Our School Resource Officers in high schools and junior high schools help bolster our relationship with Bryan students.

Compstat is the cornerstone of our crime fighting efforts. Through Compstat we seek to reduce crime through the use of crime analysis, intelligence, better communication and a problem solving approach. Our 2020 rate is 3% less than 2019. Our 2020 Part I crime rate is over 52% lower than it was in 2009. We recognize that our crime reduction over the past eleven years would not have been possible without the support of our community and the hard work of the men and women of the Bryan Police Department, many of whom you will read about later in this report.

We are an accredited agency through the Commission on Accreditation for Law Enforcement Agencies (CALEA). At the April 2020 CALEA conference we were awarded our fifth consecutive 4-year Accreditation award, with the added of "With Excellence". In addition to our CALEA accreditation, we are also accredited through the Texas Police Chiefs Association Best Practices.

The Bryan Police Department earned a Police Academy License from the Texas Commission on Law Enforcement (TCOLE) in 2018. As a result we were able to start our own Bryan Police Academy and we have graduated three classes of ten new recruits in in 2018, 2019, and 2020. We will begin of fourth class in April of 2021. All of our recruits have successfully completed their Academies and received their TCOLE certifications.

Law enforcement agencies are constantly faced with challenges. The staff of the Bryan Police Department gladly rise to these challenges and will continue to distinguish themselves by routinely demonstrating the highest levels of professionalism and resourcefulness as we move forward, providing outstanding service to the citizens of the City of Bryan.

The Patrol Services Bureau of the Bryan Police Department had a productive 2020. We are proud of the uniform we wear and proud of the service we provide to the citizens of Bryan. Each day we work to improve our internal efficiency and our external quality of service. We continue to strive for operational efficiency, crime reduction and customer service. The 2020 pandemic forced us to change how we provided services to our community. "Social distancing" and the cancellation of community engagement events distanced us from the community we serve. Patrol officers learned how to adapt to the dangers of the pandemic, while still providing quality service to the community. We responded to over 58,000 calls for service and conducted over 11,000 traffic stops. Directed patrols were utilized to apprehend wanted fugitives and to target known criminals and problem areas in an effort to further decrease crime. Our Training and Recruiting Unit had a busy year as we welcomed 11 new police officers and 1 new civilian members to the Department. We also conducted over 1796 hours of training. As the Assistant Chief of the Patrol Services Bureau, I am proud of the men and women of the Bryan Police Department and our 2020 accomplishments.



# NET

## **NEIGHBORHOOD ENFORCEMENT TEAM**



The Bryan Police Department Neighborhood Enforcement Team is dedicated to building partnerships between the police department and community members to enhance the quality of life in the City of Bryan. The Neighborhood Enforcement Team and the community members work together to identify problems and find solutions to reduce and eliminate those problems and safety concerns.

The Neighborhood Enforcement Team acts as a liaison between Bryan citizens and the police department. To maintain a strong partnership with the community the Neighborhood Enforcement Team utilizes face-to-face conversations with its residents, business owners, and religious leaders. Regularly attending neighborhood association meetings and Coffee with a Cop are two examples of ways that Neighborhood Enforcement Team Officers remain easily accessible to community members. Having a dedicated person that community members can easily communicate with has proven to be a great asset to help the Bryan Police Department maintain its Mission Statement. During these conversations with community members, Neighborhood Enforcement Officers can learn about concerns within the community and use problem-oriented policing to address these concerns.

The year 2020 has brought a new and unique challenge to the Bryan Police Department and the Neighborhood Enforcement Team. In mid-March when the COVID-19 Pandemic was just getting started the Neighborhood Enforcement Team shifted its missions and began to acquire supplies for the Police Department to keep our officers safe and the Bryan Police Department building clean. The Neighborhood Enforcement Team showed great team work and adapted to the roles necessary to assist the COVID-19 pandemic. NET accomplished the acquisition of supplies while still handling NET related complaints in neighborhoods.

The Neighborhood Enforcement Team attended 38 neighborhood association meetings, provided 65 crime prevention presentations to organizations, businesses, and other groups, and attended 137 community events. By attending some of the events in the community, the Neighborhood Enforcement Team was able to create partnerships and was able to still have a few face-to-face conversations. Keeping an open line of communication is key to learning about new problems as they arise within the community.

The Neighborhood Enforcement Team continued to support our partnership with National Night Out. National Night Out is a program held nationally that organizes community neighborhoods to come together with the police department, and other city departments, to get to know each other. The goal of National Night Out is to heighten awareness for crime and drug abuse prevention, to generate support for and participation in local anti-crime programs, strengthen police-community partnerships, and send a message to criminals letting them know that neighborhoods are organized and fighting back against criminal behavior. In 2020, the City of Bryan had only 4 block parties registered for National Night Out. Due to COVID-19, many of the block parties canceled or didn't register for safety concerns. Even though participation was down from previous years, the Bryan Police Department was selected as a City Award winner by the National Association of Town Watch for its participation in National Night Out 2020. This is the sixth consecutive year that the Bryan Police Department won this award.

The Neighborhood Enforcement Team continues to work with community members to reduce the fear of crime and improve the quality of life in the City of Bryan.



## **TRAFFIC SAFETY UNIT**

# **TSU**

The Traffic Safety Unit (TSU) is made up of four police officers and a sergeant whose primary mission is to increase the safety of the driving public in the City of Bryan. To achieve this mission, members of the Unit actively enforce traffic law, analyze collision data, utilize speed sensing equipment to raise public awareness of speeding, and make presentations to the public on traffic safety. Locations for enforcement activities are selected through analysis of high volume collision locations as well as areas where citizens complain of traffic violators. Unit members also spend time in school zones on each school day to enhance the safety of our school-aged children. Most days TSU members conduct their enforcement activities from a police motorcycle. In 2020 the unit made 2,918 traffic contacts, attended 470 training hours, responded to 592 calls for service, and made 18 arrests. TSU members are also trained in advanced accident investigation, and are called out to diagram and investigate fatality accidents and major crime scenes for

the Department. In 2020 TSU officers spent 45 man hours investigating and mapping major accidents and scenes. To assist TSU officers with fatality accident investigations, the department purchased a Bosch Crash Data Retrieval (CDR) unit, which can be used to run diagnostics on a vehicle involved in a serious crash. TSU officers also train new officers in radar/lidar use, help in scheduling, maintenance, repair of department speed sensing equipment, and assist in other areas of the department when needed. TSU personnel administer the arrangement of off-duty manpower throughout the department for funeral escorts in the city, and they personally conducted high-profile motorcade escorts for the visiting football teams during the home games for the football season. During the initial stages of the Covid-19 Pandemic, TSU officers spent several months supplementing patrol officers with their duties and placed less emphasis on traffic enforcement.

# DET DRUG ENFORCEMENT TEAM

In 2020, The Drug Enforcement Team (DET) continued with their overall objective to target and eliminate narcotics traffickers who operate in Bryan and Brazos County. DET continued to work with local, county, state and federal agencies in investigating major drug trafficking organizations that operate in Bryan.

While working with all divisions of our police department and in partnership with the citizens of Bryan, DET was able to effectively eliminate several narcotics trafficking organizations in Brazos County and inside of the City of Bryan.

With the cooperative efforts of specialized units such as the Neighborhood Enforcement Team, Criminal Intelligence Unit, and Direct Deployment Team, DET has been able to utilize their knowledge of various drug trafficking circles to identify and assist with the enforcement of various crimes in the City of Bryan, from burglary to homicide.

DET will continue working with local, county, state, and federal agencies to stem the flow of illegal drugs into the City of Bryan.

## **DDT** **DIRECTED** **DEPLOYMENT** **TEAM**

The Directed Deployment team (DDT) is comprised of five (5) officers and one (1) sergeant. The unit falls under the Special Investigations Division or SID. DDT is charged with deploying enforcement and investigative resources to address areas of the City that are experiencing high rates of violent/property crimes, street-level narcotic use and sales, suppression of criminal street gang activity and other vice related crimes, to include prostitution, gambling and alcohol related crimes. DDT is also an available asset to other units within the department requiring specialized enforcement actions to include covert and technical surveillance, fugitive tracking, undercover operations and saturation patrols. Because many street level crimes are vice related, the vice control component of the department is vested in the Directed Deployment Team.

In 2020, the Directed Deployment Team conducted a wide variety of special investigations. As in past years, the DDT focused a significant amount of time and resources targeting and arresting violent fugitives and/or persons who showed a propensity for violent behavior. The DDT also assisted both federal and state agencies in their efforts to arrest violent fugitives that sought refuge in the City of Bryan. These efforts help reduce overall violent crimes within the City.

Thefts, Burglary of Vehicles and Burglary of Habitations continue to plague the City. The DDT uses various investigative techniques to target those individuals

responsible for committing these type of crimes. For example, the DDT dismantled a group from out of town that were involved in stealing catalytic converters off vehicles in the City of Bryan. That same group was responsible for thefts in surrounding counties. DDT also utilized information from concerned citizens to recover a stolen vehicle where multiple people were arrested and several guns recovered. Those individuals that were arrested were also responsible for stealing a multitude of vehicles in this City as well as in other counties. These are just two examples of many where DDT has interrupted an organized group that was responsible for a large numbers of thefts.

Based on community complaints, the DDT spent several months in a local neighborhood in south central Bryan. The residents complained of loud music, drug sales, intoxicated persons, speeders and general disorderly conduct. Multiple search warrants were served on local drug dealer residents and many arrested for various criminal offenses. A two week patrol saturation was also put in place with 24/7 coverage in the neighborhood. The results of those efforts yielded a significant reduction in calls for service.

DDT will continue to use a variety of special investigative techniques as well as information provided by concerned citizens in its effort to improve the quality of life for all Bryan residents. The DDT encourages you to call (979) 209-5452 with information regarding vice related crimes.

# K-9 K-9 UNIT

In 2020, the Bryan Police Department continued to operate with a single K9 team of Officer LeBlanc and K9 Blitz. Officer LeBlanc and K9 Blitz continued to serve the needs of the Bryan Police Department and surrounding agencies through both illegal narcotic detection and patrol deployments. Officer LeBlanc and Blitz are dual certified through PSP for both patrol deployments and illegal narcotic detection. Blitz is certified to detect the odor of marijuana, cocaine, methamphetamine and heroin. For patrol deployments, Blitz is used to apprehend suspects, track suspects, detain suspects, search open areas for suspects, conduct building searches for suspects and search areas for evidence. During 2020 Officer LeBlanc and Blitz were called upon to assisted the Texas Department of Public Safety, Brazos County Sherriff's Office, College Station Police Department, Burleson County Sherriff's Office and the Hearne Police Department. Officer LeBlanc and Blitz are assigned to the Patrol Division. They assist other units and teams of the Bryan Police Department in order to accomplish the various goals and missions of those various units and teams within the department. Officer LeBlanc and K9 Blitz deployed 41 times in 2020 for illegal narcotic detection, searching various



vehicles and other locations for illegal drugs. This resulted in the seizure of marijuana, cocaine, methamphetamine and heroin. Officer LeBlanc and Blitz had 19 patrol deployments resulting in the apprehension and arrest of multiple suspects and the recovery of evidentiary items.

The Bryan Police Department K9 Unit has continued to build positive relationships with the community through our K9 demonstrations. These demonstrations allow both children and adults the opportunity to learn about our K9 program, see K9 Blitz in action, and of course meet K9 Blitz. We conducted these K9 demonstrations for various youth organizations, student organizations and special events held throughout the community. The K9 unit will continue to develop relationships with the community and be a positive image for the Bryan Police Department.

# RPF RESERVE POLICE FORCE

The Bryan Police Department Reserve Police Force is comprised of six dedicated Reserve Police Officers.

The Reserve Officers all have full-time, regular jobs outside of the police department, but they have taken an oath to voluntarily provide police services to citizens of Bryan. The Reserve Police Force provided security for numerous non-profit fundraising events and several City of Bryan events such as races, festivals, and parades. In addition to staffing special events, the Reserve Police Force provides security for First Friday in Historic Downtown Bryan, worked the Retail Merchant Close Patrol Program, and supplemented staffing on daily patrol when available. Although many community events were canceled due to the pandemic, the Reserve Police Force logged over 781 hours of volunteer duty time during 2020.

## TRAINING & RECRUITING

The Training and Recruiting Unit for the Bryan Police Department is responsible for recruiting and hiring new officers, training all current certified officers at the Department, as well as running the Basic Peace Officer Academy. A team of five officers, one sergeant, and one civilian conduct training and document maintenance of all certified officers in the Department.

Bryan Police Officers are required to qualify with their firearms, recertify with less lethal weapons, and receive 40 hours of in-service training each year. This year's in-service training focused on Eyewitness Identification, Response to Active Shooter, Spontaneous Knife Defense, and Gracie Survival Defensive Tactics. Each officer attends approximately 47 hours of law enforcement training on average each year. This year the Unit provided 1676 hours of training to officers at the Police Department.

In 2020, Training and Recruiting Unit successfully completed their Third Basic Police Academy. The Academy is a 22 week long program and covers 41 subjects. All 13 Cadets in the Academy passed the Texas State licensing exam on their first attempt. The Academy currently has a 100% pass rate and the Training and Recruiting Unit has already started preparations for fourth Academy in 2021.

The Training and Recruiting Unit attended several job fairs in an attempt to recruit officers from around the state, as well as recruiting on-line. During 2020, the Department hired 11 officers.

# CSU

## CRIME SCENE UNIT

The Crime Scene Unit is comprised of 3 Forensic investigators and 1 supervisor/investigator. The CSU responds to major scenes involving deaths, including fatality accidents, life threatening injuries, robberies and some burglaries and scenes where video evidence needs to be recovered. The CSU also downloads cellular phones, and processes evidence that has been collected for DNA recovery and latent fingerprints. They then examine the prints that are collected during processing and from Patrol Services for suitability in entry into AFIS and compare them with the known prints of suspects. During 2020 the CSU was involved in 881 cases, generating 1209 supplements and responded to 168 crime scenes. 45 of those scenes were death investigations. The BPD CSU also assisted in 59 cases from several outside agencies including:

The CSU also taught Forensic related courses at Texas Division of the International Association of Identification, the Bryan Police academy, and the Intermediate level Crime Scene course for police officers. Members of the CSU have also been involved with the local organizations such as, the Bryan Police Officer's Association.

# CIU **CRIMINAL INTELLIGENCE UNIT**



The Criminal Intelligence Unit (CIU) gathers information from submitted reports, interviews, and crime tips in order to track trends and attempt to project future areas of criminal activity. This information is shared with Bryan PD Units and outside agencies in an effort to assist with the prevention and reduction of crime, and to assist solving crimes that have been committed. CIU is also tasked with tracking and documenting local gangs and their activities and compiling the monthly departmental racial profiling reports. They maintain the Department's gang database and ensure that it complies with all State and Federal laws as well as ensuring that all files are up-to-date with pertinent information.

During 2020, while enduring the Covid 19 pandemic, members of CIU handled a combined 561 requests for assistance from different divisions within Bryan PD and 541 requests from outside agencies. Through information gained by CIU, a total of 623 law enforcement informational bulletins and emails were issued to BPD as well as to local and surrounding agencies. Members of CIU gave expert testimony or assisted in local judicial proceedings, which resulted in a combined total of over 200 years of incarceration time sentenced to local gang members through Brazos County courts. The primary CIU gang officer helped identify numerous gang members for prosecutors and outside agencies over the past year. CIU members executed and/or assisted with a combined 45 specialized operations throughout the past year (search warrants, surveillance ops, various protests and demonstrations, etc.), worked on 122 special projects, wrote parole protest letters, bond increases for habitual offenders and gang profiles for multiple trials

involving gang members. CIU was also responsible for the identification of numerous suspects involved in Bryan PD and other law enforcement agency criminal cases such as robberies, homicides, burglaries, assaults, and major thefts in the Brazos Valley and surrounding areas.

Some examples of CIU's success this past year comes from information sharing with outside agencies like College Station PD and the Brazos County Sheriff's Office. One such instance dealt with a suspicious person at one of the elementary schools in Bryan, where the person was reported to have been following Pre-K children. A criminal intelligence bulletin was created and shared with surrounding agencies. College Station PD had a similar call with the same person and was able to share their findings with our department. The incident was investigated and the person was issued a criminal trespass warning. Another example was the result of a daily data base search for stolen property where a known burglar/thief had pawned traceable property at one of our local pawn shops. The property was not reported stolen in Bryan, so email messages were sent to CSPD and BCSO to notify them of the possible stolen items. BCSO replied and advised that the property in question had been stolen from a burglary that was reported in the County. Warrants were obtained by BCSO and the suspect was later arrested. These few examples highlight the diligence of CIU and its members and the need for continued information sharing and networking between area law enforcement agencies.

Part of the CIU function involves instructing the community in the prevention of crime and in understanding issues that affect them as a whole. CIU generally conducts presentations to the Bryan PD CPA, the Spanish CPA, BPD School Resource Officers and new officers, but due to the Covid 19 pandemic and the restrictions on training, only SROs and new officers received training and instruction from CIU members this year.

The two intelligence officers within CIU take on a variety of roles within the Department in addition to their intelligence officer duties. Both officers are active members of the area wide Critical Incident Stress Management Team, active members of the Department's Peer Support Team and both are members of the Emergency Response Unit with one assigned to the Tactical Response Team and the other assigned to the Crisis Negotiations Team.

CIU continues to be an active and successful part of the Special Investigations Division and Bryan PD as whole, helping to combat and prevent crime in Bryan.

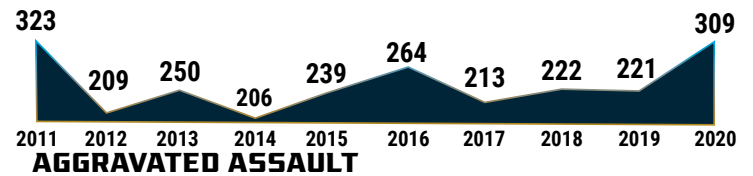
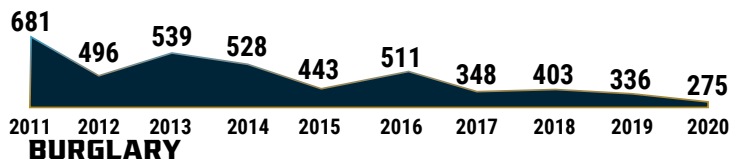
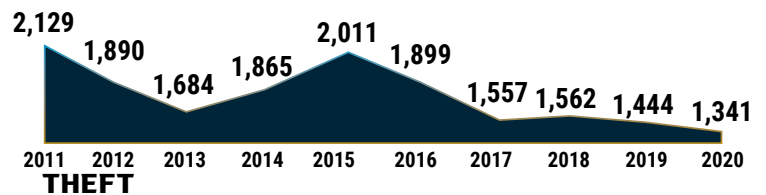
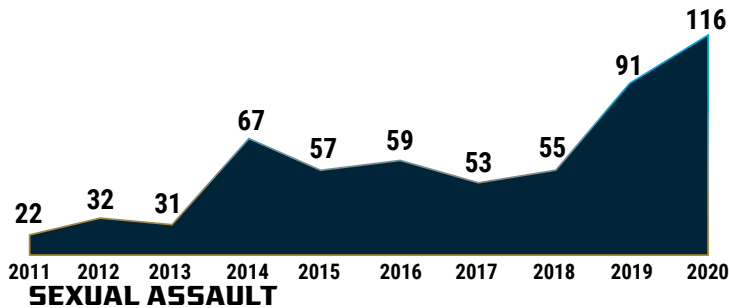
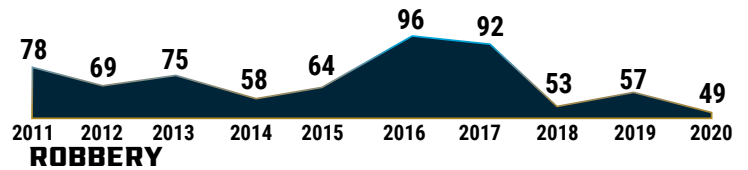
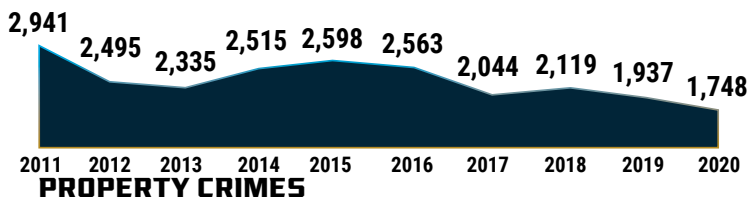
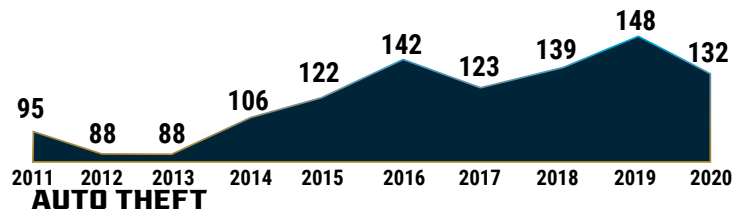
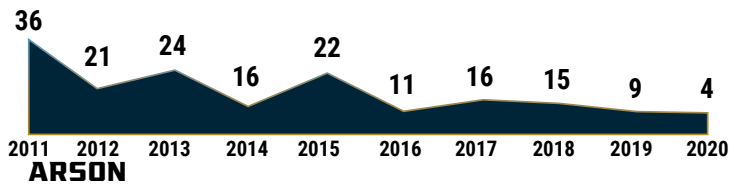
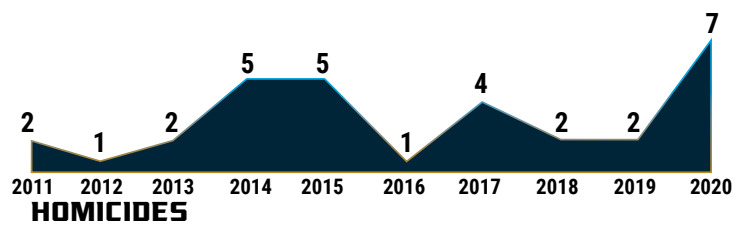
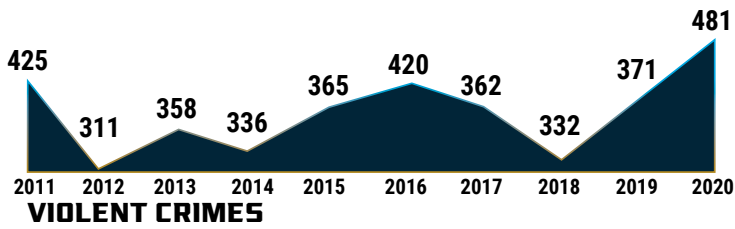
The Criminal Investigation Division is responsible for conducting follow-up investigations of reported crimes. The Division is divided into three investigative units, Property Crimes Unit (burglary, thefts, fraud, etc.), Crimes Against Persons Unit (assaults, harassment, juvenile crime, missing persons and robbery), and Major Crimes Unit (homicide and suspicious deaths, and aggravated robbery). The Crime Scene Unit is also a part of the Criminal Investigations Division and this non-sworn group helps to collect and analyze evidence for detection and prosecution of criminal suspects. A Crime Victim's liaison is also assigned to the Division to help support our crime victims as they navigate through the investigation and prosecution of their crimes. Each Investigative Unit is assigned sworn and non-sworn personnel and work complimentary to one another in our efforts to solve crimes.

In 2020, the Property Crimes Unit addressed burglaries of buildings, habitations, and vehicles through operations involving Detectives, Special Investigations Investigators, and Patrol Officers. Property Crimes Detectives meet and coordinate efforts to identify criminals and recover property through frequent meetings with area investigators and help from our citizens. Private residential surveillance footage shared with the Department from our citizens has helped us develop more leads and impact property crimes this year. The Crimes Against Persons Unit has coordinated efforts with local investigators, prosecutors, and health

services providers to reach more victims and provide greater after offense care for those affected by crime. These efforts have allowed us to better meet the needs of our community members who need services from the police, courts, and emotional/health care providers in the most efficient manner. The Major Crimes Unit responded to seven Homicide investigations in 2020 and were able to identify and arrest the suspects in all but two cases. Major Crimes was also able to identify and arrest several suspects of Aggravated Robbery involved in multiple incidents. Major Crimes Detectives continue to work leads and follow up with possible witnesses and involved persons in these to homicides. These arrests were made possible through vigorous investigations and cooperative efforts throughout the department and community.

The Criminal Investigations Division partners with all local, State, and Federal law enforcement and social service agencies to positively impact crime and provide victim and witness support to those who are affected by criminal activities. As crime trends evolve and affect our community with technological advances it is important for us to communicate and consolidate our efforts with all of our partners while also seeking training and practical experience with available technology. The Criminal Investigations Division appreciates the Community's consideration and assistance with sharing private residential and business recordings that enhance our investigations.
